About the Statement of the Regulations on the III International Children and Youth Award "Ecology is Everyone"

In accordance with paragraph 2 of Article 74 of the Federal Law from 10.01.2002 № 7-FZ "On protection of the environment", in order to implement Presidential Decree of 21.07.2020 № 474 On the national development goals of the Russian Federation for the period till 2030", I hereby resolve as follows:

Regulations of the III International Children's and Youth Award "Ecology is Everyone"

I. General provisions

- 1. This Regulations of the III International Children's and Youth Award "Ecology is Everyone" (hereinafter the Regulations, the Award) define the general provisions of the award, goals, objectives, conditions, terms of its holding, the nominations and evaluation criteria for the submitted works, as well as the requirements for their registration.
- The Award is approved by the Federal Service for Supervision of Natural Resources.
 - The organizer of the Award is Rosprirodnadzor.
- Technical and organizational support of the Award is provided by the Operator as determined by the Award Organizer.
- The official address of the Award in the information and telecommunication network "Internet" is https://экологияделокаждого.рф и http://ecologyiseveryone.ru.
- The Regulations are published on the official website of the Award in Russian and English.

II. Aims and purposes of the Award

7. The Award is held in accordance with the national development goals of the Russian Federation (hereinafter - the national goals) set forth in the Decree of the President of the Russian Federation No. 474 of July 21, 2020 "On the national development goals of the Russian Federation for the period up to 2030", which include people's health and well-being, opportunities for self-realization and development of talents, a comfortable and safe living environment, and digital transformation:

"Opportunities for self-realization and development of talents" by creating conditions for identifying, supporting and developing the abilities and talents of children and young people, aimed at their self-determination and vocational guidance, and increasing the percentage of citizens engaged in volunteer activities or involved in volunteering (volunteer) organizations;

"Comfortable and safe environment for life" by attracting the attention of children and youth, citizens of the older generation to the topic of separate garbage collection and solid waste management; "Digital transformation" through the development of "digital maturity" of citizens, their ability to form and post on social networks photo and video content that does not contradict social norms accepted in a civilized society.

- 8. The aim of the Award is to popularize the topic of ecology, careful attitude to nature and the environment among citizens, to encourage their participation in environmental education activities with the help of Internet resources, artistic, multimedia, online and technical means, as well as environmental education of the participants, increasing the level of their environmental culture, responsibility, education and literacy; developing the public activity of children and youth environmental organizations (including volunteer organizations) in the general education system and in the system of supplementary education for children during competitions; encouraging citizens engaged in environmental education for children and youth.
 - 9. Objectives of the Award:

ecological education of citizens, including children and youth;

identification of talented and capable children and young people who present their own views on environmental problems

in the world around them within the Award nominations;

involving citizens in environmental volunteer activities;

developing professional preferences of young people in the field of environmental activities;

involving parents in joint environmental activities with their children and presenting them through online resources, art, photography

and video tools:

drawing the attention of citizens to the study of the natural features and biodiversity of their country and small homeland;

identifying and supporting mentors, educators, public figures, volunteers, bloggers, journalists, students, and opinion leaders engaged in environmental education among children and youth;

international exchange of experience in the area of citizens' understanding, representation and contribution to improving the environmental situation in their communities and countries of residence:

supporting Russian and international educational organizations, organizations for orphans and children left without support to Russian and international organizations of all types of orphans and children deprived of parental care and to specialized institutions supporting Russian and international educational organizations for orphans and children deprived of parental care of all types, and specialized institutions for minors in need of social rehabilitation, supplementary educational institutions for children, and public organizations and movements that develop and promote healthy lifestyles. and the high importance of an eco-friendly environment.

III. Stages and duration of the Award

Duration of the Award: from March 1, 2023 to March 1, 2024.

- 11. Deadline for submission of applications for participation in the competitive events: from 00 h 01 min (GMT+3 time zone) March 1, 2023 to 23 h 59 min (GMT+3 time zone) October 1, 2023 (inclusive).
- 12. Work of the Organizing Committee on the initial selection of materials, the formation of the short-list for all nominations and age groups, the preparation of works for consideration by the jury: from March 1, 2023 to October 15, 2023 (inclusive). The composition of the Organizing Committee shall be determined by the Award Operator.
- 13. The Jury's evaluation of the short-listed works and summing up the results of the competitions for the Award takes place from October 16, 2023 to November 10, 2023 (inclusive). The composition of the jury is determined by the Organizer of the Award.
- 14. The announcement of the winners and award-winners of the Award will take place after the results of the competitions have been summed up for the nomination of the Award in 2023. The date of the announcement of the laureates (winners) and award-winners of the Award shall be determined by the Organizing Committee.
- Awarding of laureates (winners) and award-winners of the Award: until March 1, 2024.
- 16. During the period of the Award, the organizer shall have the right to hold competitions, promotions and other events aimed at popularizing the Award, its goals and objectives and expanding the reach of the participants. The terms and conditions of such events are stipulated separately.

IV. Conditions for holding the Award

- 17. The Award presupposes participation in competitive events in two formats: individual and team.
- 18. When submitting an application, the original video material of the work shall be provided on a mandatory basis.
 - 19. No work shall be considered or published if it: does not meet the requirements of these Regulations

and/or methodological explanations for the Award nominations;

violates the legislation of the Russian Federation;

has unethical, obscene, indecent, offensive

and/or immoral content;

contains calls for cruelty, violence, calls of a political, extremist nature, information that may harm the health and/or development of children;

encourages the commission of unlawful acts;

contains overt or covert advertising, third-party trademarks, religious or political symbols;

offends the honor and dignity and/or violates the rights of third parties; is not available for viewing;

previously accepted for another Award nomination;

exceeds the time limit for a contest video or animation clip.

- 20. The works recognized by the Organizing Committee as compliant with these Regulations and the Methodological Explanations for the Award nominations shall be published on the official website of the Award.
 - The Organizer of the Award reserves the right:

to use the submitted works for non-commercial purposes, including, but not limited to, social advertising campaigns, without prior notification to the author and without payment of any remuneration;

to send the submitted works for participation in Russian and international competitions, including on behalf of the participant of the Award, without charging the Participant of the Award any fees, if it is required by the rules of the corresponding competition. All costs shall be borne by the Organizer of the Award.

- Lists of the laureates (winners) and awardees of the Award shall be posted on the official website of the Award https://exonorusgenokaждого.ph and http://ecologyiseveryone.ru.
- 23. Laureates (winners) and award-winners of the Award shall be awarded diplomas of the first, second and third degrees in the stated nominations and age groups, diplomas of the first, second and third degrees from the Chairman of the Jury and gifts. Separately, the winner shall be awarded the Grand Prix of the Award.
- 24. The participants of the Award, whose works were sent to participate in Russian and international competitions at the discretion of the Organizer of the Award, receive prizes, diplomas, certificates provided for in the regulations of the corresponding competition, if they win the corresponding competition.
- The Organizer and the Jury have the right to reward the participants of the Award with special award diplomas and certificates.
- 26. All participants (individuals, organizations, institutions and movements), whose applications were accepted and published on the website of the Award, shall receive an electronic certificate of participation in the Award from the Awards Organizer.
 - 27. The Organizer shall have the right to award letters of gratitude to:

Russian and international educational organizations, organizations for orphans and children left without parental care of all types, specialized institutions for minors in need of social rehabilitation, institutions of additional education for children, public organizations and movements, whose students, pupils or participants participated in the competitive events of the Award;

Teachers/educators/guardians/curators, who supported the participation of children and young people in the competitive events of the Award.

28. Laureates (winners), award-winners of the Award and other participants (in the case of minors, their legal representatives), who are applying for for receiving the gift shall be obliged to provide the Award Operator with all the necessary information (full surname, first name, patronymic; copies of their national passport pages, including the page with the current registration address; taxpayer identification number (TIN); postal address for gift delivery and/or

acceptance certificate; bank details; other documents and information necessary for gift delivery, at the request of the Operator).

The participants of the Award (for minors - their legal representatives) shall provide the Organizer and the Operator with the originals of the above documents (materials) for verification against the copies of such documents/materials submitted earlier.

Laureates (winners), award-winners of the Award and other participants (in case of minors - their legal representatives) undertake to sign all the documents related to the receipt of the gifts. The Organizer and the Operator shall be obliged to from the Organizer and the Operator only after receipt of the original signed documents necessary for gift giving. Otherwise, the participant is considered to refuse to receive a gift, and the gift is considered unclaimed.

V. Award Nominations and Evaluation Criteria

Nomination "Eco World"

Age groups:

The first age group - children from 6 to 9 years old (inclusive);

The second age group - children from 10 to 13 years old (inclusive);

the third age group - teenagers from 14 to 17 years old (inclusive).

Requirements to the nomination: individual participation, the video must be uploaded on the official website of the Award https://экологияделокаждого.рф

(http://ecologyiseveryone.ru) when applying for participation.

The task of the nomination: to present by the participant of the Award his own subjective view on the created image of the environmental world around him, solutions of environmental problems, positive environmental initiatives available in the place of residence of the participant, to draw attention to the solution of environmental problems in a creative form (dance, song, poem of his own composition, etc.).

Format: video clip, duration from 15 seconds up to 1 minute. Shortlisted works in this nomination will be evaluated by the jury. Criteria and indicators of evaluation of the nomination "Eco World":

Applications are accepted from schoolchildren, students, mentors, teachers, public figures, volunteers, bloggers, journalists, students, opinion leaders engaged in ecological education.

Objectives of the nomination: to popularize the theme of environmental education among children, youth and adults, the theme of conservation of animals

and plants included in the Red Book, the preservation of wild fauna and flora, endangered species; to promote scientific and project activities in the field of environmental conservation, ecology, environmental education through various activities (volunteering, conducting environmental events, creating educational visual and audio content, educational and entertaining).

Format: video, up to 3 minutes. The maximum duration may be increased in exceptional cases by decision of the Organizing Committee.

Objective of the nomination: to popularize the theme of environmental preservation, respect for nature and increase the level of ecological culture of children and teenagers by means of visual art.

Format: scanned images of drawings made on paper,

The file with the drawing should be in jpg format and the size should not exceed 5 Mb and the resolution should not be less than 1920 pixels on the short side.

The organizer has the right to request the original working file of the computer drawing if necessary.

The work must be uploaded on the official website of the Award https://экологияделокаждого.рф (http://ecologyiseveryone.ru) when applying for participation.

The aim of the nomination: to popularize the theme of ecology through the lens of a camera and to draw attention to ecological problems and issues of nature and environmental conservation in children of different age groups.

Format: the photo shall be submitted in electronic form, in a jpg format graphic file with a maximum size of 5 MB and a resolution of not less than 1920 pixels on the short side.

The organizer has the right to request the original file of the photo without processing, if necessary.

The application is submitted by one of the children.

Objectives of the nomination: to popularize the theme of ecological family education and increase the level of ecological culture of children and teenagers; to present the experience of families with children in carrying out ecological actions in different formats and genres, reflecting the promotion of ecological well-being.

Objectives of the nomination: to present a video clip on an environmental event "from the beginning to the end", which was held in an educational organization, specialized institution, institution of additional education, public organization

carry out a large-scale environmental event (eco action, eco flashmob), reflecting the maximum involvement of a large number of children and adolescents, members of the public to promote respect for nature

VI. Conditions of participation in the Award

Competitive events for the award shall be attended by:

children and young people living both in the territory of the Russian Federation and abroad and who are studying in Russian and international educational organizations, institutions of supplementary education for children or are being trained in a family environment;

adult citizens living in the Russian Federation and outside the Russian Federation.

- 42. Participants of competitive events for the awarding of the Award (individually or as part of a team) are the authors of the submitted creative works. Responsibility for the authorship of the work and compliance with copyright and related rights under the legislation of the Russian Federation shall be borne by the person submitting the work for the Award.
- 43. The age of the participants shall be taken into account at the time of submission of the application.
- 44. Videos, animations, photos, files with drawings must be uploaded on the official website of the Award https://экологияделокаждого.рф (http://ecologyiseveryone.ru) when applying for participation.
- 45. It is forbidden to submit for the Award creative works previously submitted to the International Children's and Youth Award "Ecology is Everyone" and the II International Children's and Youth Award "Ecology is Everyone" in 2021 and 2022 respectively.
- 46. Video clip, animation clip, photo and drawing submitted for the Award should be made (filmed, drawn) not earlier than 2022.
- 47. The organizer reserves the right to subject the authorship and originality of the competition works to any scrutiny.
 - 48. Individual or team participation formats include:

registration of a personal profile (cabinet) on the Award site selecting a nomination;

correct filling of all mandatory fields of the application form

on the official site of the Award (separately for individual and team participants) for each work;

unconditional consent to process the personal data of the author and the Author's legal representative (Appendix 1 to the Regulations); unconditional consent of the author (legal representative of the author)

for publication/publication of materials

and their use for informational, scientific, educational or cultural purposes (Appendix 2 to the Regulations);

unconditional consent of the author (legal representative of the author)

for the publication/publication of materials

and their use with the purpose of participation in the Russian and international contests (Appendix 3 to the Regulations);

the use of the works, photos and videos of the participants in social networks, on the website of the Award for the competitive events;

use of sent works, participants' personal data for participation in Russian and international competitions;

submission (attachment) of the work in accordance with the requirements of these Regulations and the Methodological explanations for the nominations of the Award.

- 49. By registering on the Award website, the participant (his/her legal representative), mentor confirms that he/she has read, accepts fully accepts and agrees with these Regulations and provides consent to the processing of his/her personal data (Appendix 1), consent to the publication/placement of materials in the public domain and their use for informational, scientific, educational or cultural purposes (Appendix 2), and its use for informational, scientific, educational or cultural purposes (Appendix 2), consent to publication/publication of materials and their use for the purpose of participation in Russian and international competitions (Appendix 3), and consent to publication/placement of materials in the public domain (Appendix 4). - 52. The Participant of the Award authorizes the Organizer to make changes to the entries, provide comments, explanations, captions.
 - Participation in the Award is free of charge.

- 54. The registration of more than one personal profile on the Award website for one and the same participant shall not be permitted.
- 55. In the event of a dispute over the intellectual rights to the creative work, the Organizer has the right to exclude the participant from further participation in the Award, and the result of the evaluation of his/her work, including the decision to award its author as a laureate (winner) / winner of the Award, be annulled.
- 56. The Organizer has the right to combine the age groups based on the number of the nominated works.
- No objections, appeals, claims about the initial selection of materials, formation of the short-list and the results of the Award are allowed.
- 58. Applications for participation in competitive events for the Award later than the specified deadline shall not be considered.
- 59. Responsibility for incorrect or erroneous personal data with incorrect e-mail, name, surname, patronymic, address, etc. rests on the participant (his legal representative).
- 60. Participation in the video clip directly of the participant/participants is obligatory in the number indicated in the application.
- 61. The Organizer reserves the right to use the contact information of the participants and mentors indicated in the registration on the Award website to send out information to the address within the framework of the Award (if necessary).

VII. Formalization of works submitted for the Award

62. Works shall be submitted in electronic form:

drawing, photograph (graphic jpg files of A4 or A3 format jpg files with the correct aspect ratio, no more than 5 MB and at least 1920 pixels on the short side of the image);

video, animation clip (mp4 format, not more than 300 MB; timing - 1 minute is welcome, but must not be less than 15 seconds and more than 3 minutes; not less than 480 pixels on the short side of the visible image).

63. Language of the works: Russian, English, Spanish. Works submitted in a language other than Russian must be accompanied by a voice-over translation or subtitles in Russian.

VIII. Final provisions

- 64. The Organizer and the Operator shall not reimburse any expenses incurred by the participants in connection with their participation in the Award.
- 65. The Organizer and the Operator shall not be liable for failures or malfunctioning of computer networks, communication networks and data transfer; technical failures, technical malfunctions on the Award site if they are not the fault of the Organizer and the Operator; copying and distribution of the creative works from the web pages of the Award by third parties.

- 66. The Operator of the Award notifies the laureates (winners) and awardwinners (for minors - their legal representatives) of the results of the review of their entries and provides instructions for their further actions.
- 67. The Organizer and the Operator of the Award do not send a notification to the participants about the results of the review of the entries submitted by them and does not give explanations about the reasons why the entries were not supported and/or published, including information about the assessments and conclusions of the jury.
- 68. The Participant who has applied for the Award shall bear the risk of the consequences of non-receipt of meaningful messages sent by the Organizer to the email address specified by such Participant in his application for the Award.
- The methodological explanations for the Award's nominations shall be posted on the official website of the Award.
- 70. In case any changes are made to these Regulations, they shall be published on the website of the Award. If a participant continues to participate in the Award, he/she expresses consent to the amendments made to this Regulations.
- 71. The Organizer and the Operator of the Award shall not be liable for for non-fulfillment of any obligations under these Regulations caused by force majeure circumstances (force majeure).

Force majeure includes: epidemics; natural disasters (floods, tornadoes, earthquakes, etc.); restrictive measures of the authorities by the authorities, as well as laws, regulations and other regulatory documents of the competent state authorities adopted after the publication of these Regulations and preventing its implementation.
